If publication is approved the reader shall ensure that any acknowledgement which RBS requires is included and that RBS Archives is advised of the date, place and manner of intended publication.
4. You may only save, view or hold the pdfs on an electronic storage medium which is at all times under your direct control.
5. You may not supply to, permit access to or make copies of the pdfs or the digital images they contain for any person/institution. You may not supply the password provided to access the pdfs to any person/institution.
6. No reuse or reproduction of the pdfs or the digital images they contain is permitted, except upon submission and approval of a 'Reproduction of Archive and Art Materials Licence', available on request.
